Resolution #2017 - 71

Authorization for Execution of Agreement for Wastewater Treatment Capacity for the Provision of Affordable Housing

Mr. Watts – This is nothing that had been discussed at the prior meeting, this came up since the last meeting. We held a meeting in my office with representatives from Raritan Township, they are in need of additional capacity on an expedited basis to fulfill the interim COAH requirements. They received a favorable ruling that they only needed a certain amount to fulfill this round and we had that available so we took the liberty of preparing not only the Resolution but also the Agreement; the Agreement hasn't been approved by Raritan Township yet but I wanted to get something before you. What they are asking for is that we transfer a certain amount of capacity, as we did back in 2006, to be used solely for COAH projects. You'll see in the Agreement and in the Resolution, we don't know where it's going or when they're going to use it or how they're going to use it, but we are transferring it to them, it's their decision, it can

only be used for COAH projects and the income from it will only begin to come when it's transferred, with our approval, to the developer of the COAH project. If you'll notice, in the past we had a duration of two years. That wasn't discussed with the Township so I left it blank and I would say we can leave it blank with the understanding that it will not be signed by the Chairman until the duration of the Agreement has been agreed upon. Other than that, it's exactly the same as we did with the Township in 2006 and it worked very well.

Dr. Buza – So if this doesn't go forward the capacity comes back to us? Mr. Watts – Yes.

- Mr. Madden This has to do with Raritan Town Square and they want to transfer ownership of EDUs from one site to another and I understand you guys don't do that.
 - Mr. LaFerla We don't allow that.
- Mr. Watts The properties have to be contiguous and have the same ownership.
- Mr. Kendzulak, Jr. I'd like to talk about this in Closed Session if that's possible?
- Mr. Watts You would have to deem it a Contractual Matter because you have Contracts to reserve capacity with them.

- b) Engineer –

Mr. Madden – We've been getting good data from the meters. The issues seem to be from a couple of different areas. I thought maybe we would find one

key spot but unfortunately it seems to be a little spread out. Mr. LaFerla's guys have gone out and done some more field work, some more investigation and we've come up with a couple of spots that we need to look at a little closer. There are some leaks and things we've found. Things we can repair and get good benefit from.

- Mr. Kinsella So is there anything specific that you've found that you can report on?
 - Mr. Madden No magic bullet.
- Mr. Kinsella No magic bullet, but do you see a trend, do you see something specific happening, something reoccurring in one spot?
- Mr. Madden We have a meter upstream on Dayton Road, and that seems to be an area where they're having a pretty good jump during wet weather, like four times the normal flow.
 - Mr. Kinsella That's residences that are feeding that.
 - Mr. Kendzulak, Jr. Where on Dayton Road?
- Mr. Madden Meadowbrook. There's a stream back there and the pipe runs along that.
- Mr. Kendzulak, Jr. What I would like, perhaps for the next meeting, is you could be prepared to give us a presentation; this is where we are, this is what we found, what the next steps are now. As the Authority moves forward, this is a critical undertaking that we have. Hopefully we get a little more rain.
- Mr. Madden We can definitely do that, that's not a problem. We met with Johanna Foods; we've been working with the Contractor and Mott MacDonald reviewing shop drawings for the Route 31 Interceptor Relocation, so that seems to be getting ready to go. Commerce Street, we've been reaching out to that Contractor, I think maybe by the end of the month. I've suggested they do it at night because it'll just be a lot easier traffic wise. I think most of the businesses shut down overnight so they'd have less flow to deal with and bypass.
- Mr. Kinsella Just to go back to the Johanna Foods meeting; Mr. LaFerla and I were there too. What I understood from their head, Mr. Facchina and Mr. Saracini is if this injection thing works according to what they have been told, they will save 50% of their flow that would come here. So, that's about 150,000 gallons per day; that's very significant and that would open up a lot of capacity. If in fact it works. They asked if we were behind them and we said of course we were and they said they'd heard elsewhere that we were not.
 - Mrs. Robitzski Do we have the authority to approve or disapprove this?
 - Mr. LaFerla They have to get the okay to do it from DEP.
- Mr. Watts They are a customer. They can do whatever they want if they find another way to get rid of their wastewater; they stop sending it to us and we stop billing them.

Mr. Madden – It would make sense to get rid of this extra flow. It frees up the whole section of where we have issues.

Mr. Kendzulak, Jr. – What's the optimism of DEP approving this and this thing moving forward and a timeline?

Mr. LaFerla – We met with them maybe three years ago and heard the same thing and it hasn't moved at all.

Mr. Kinsella – I spoke to DEP about two months ago, the gentleman told me the last time they approved one of these things was about eight years ago. That could have been in the middle of south Jersey without any houses around for miles.

Mr. Madden – That's going to be the issue, how it affects the groundwater.

6. RTMUA REPORTS:

a) ADMINISTRATIVE / OPERATIONS REPORT

1. Chief Operator / Director's Report

Mr. Kendzulak, Jr. – Just a note about the septage in October, it's almost \$51,000.00, last year in October it was just under \$25,000.00; it almost doubled. Why?

Mr. LaFerla – Phillipsburg still hasn't opened back up; they're still down. They're prices will probably go up when they reopen because they're going to have a bill to pay.

Mr. Kinsella – Number six on your report about the discharge from Johanna Foods.

Mr. LaFerla – The guys were out TVing lines over by Midas and when they went to check a manhole, the creek that runs right by there, the creek was white. They started following it back and called me so we called the DEP Hotline, and also the Hunterdon County Health Department and we sent both of them pictures. They both came out after they saw the pictures. They followed it upstream and it was coming down a dry ravine and they followed it up the ravine and it was getting pumped out of Johanna Foods. Then the DEP took over. I'm sure they'll make them clean the stream and whatever. They had an illegal outfall, and somehow there was a sump pump pumping it out to this illegal outfall that they didn't know about. The only other thing I want to mention is there's a Loss Control Report in there; Mr. Sciss is doing a very good job down there with everything.

Mr. Kinsella – I have a question about this. It has to do with mats. This is at the Motor Control Center. These mats should have been part of the job that was done. It's a standard safety concern. Either Mott MacDonald didn't specify that they should be there or else DeMaio didn't put them there when they should have put them there. That's how I read it, that this guy is saying they should have

been there.

Mr. Kendzulak, Jr. – Was it left out in the design or was it left out of the job and the guy didn't do what he was supposed to do. We need to look into it. Ask them to review this and provide an explanation.

Mr. Kinsella – These things aren't cheap and safety is paramount down there, it's serious stuff. I think they should have been incorporated into this job and I don't think we should have to be paying for this.

Mr. Kendzulak, Jr. – Ms. Nicaretta, please make this an agenda item for next month.
