from Bowman & Company, our -

MR. WATTS: John, just pace yourself a little bit, because the court reporter's taking everything down.

MR. KENDZULAK: Oh, okay. Yes. Will do. I can give you a copy of this, if you like.

VICE CHAIR HAZARD: No mumbling.

MR. KENDZULAK: The 2023 budget includes \$7.1 million in operating appropriations (Sheet F-1), which is a 2.9 percent increase in operating appropriations, or approximately \$200,000 more than the 2022 operating budget.

Also included in the 2023 budget is \$3.2 million in capital budget appropriations (Sheet CB-3), with approximately 2.5 million funded through the utilization of net position from projects that were unable to be completed in prior years, but have already been budgeted for. Additionally, the authority plans to fund \$670,000 of capital appropriations through the issuance of debt.

The authority is able to raise the anticipated revenues of \$7,760,400 (Sheet F-2) through the existing rates, and a rate increase to support the budget is not required.

1	Additionally, as a result of the
2	connection fee calculation, as of December 31,
3	2021, the connection fee will increase by \$163,
4	from \$4,246 to \$4,409. This increase is based on
5	increases to the capital base through debt
6	payments and capital asset acquisitions.

Mr. Tully – We are going to go a little out of order tonight and do the Citizen's Privilege part of the meeting. We read up on everything, give us your own over view; Mr. Cooper, the floor is yours.

Mr. Chris Cooper - Prior to working here, I worked at Frenchtown Borough, and I started there June 10<sup>th</sup> of 1991. I was on a probationary period for six or seven months. January of 1992 is when they put me on the pension and health benefits and all of that. I didn't know that they didn't pay back those seven months towards my pension. I don't remember how many years ago it was, the Governor said, "you have a deadline of June 28, 2011; if you have twenty years in by then, you can have your benefits fully paid on retirement." When I did the calculations, I did it from the day I started at Frenchtown, and I made it and I assumed all of this time that I made it within the twenty years. I am planning on retiring, so the last year or so I started to work on my stuff. When Mrs. Struening was here, she let me know that according to the Pension, they have me down as starting as of January 1992 and it makes me seven months short. I told them that I started in June as a full-time employee. Mrs. Gano checked in with them and they said they had me down as a part-time employee for those seven months; I have the paperwork from the minutes when I was hired, and I was a full – time employee. When I did all of the calculations, they said I was short. I called the Pension and asked them if I could buy back those six or seven months. Here, at RTMUA, they pay the Pension back from when you start on probation, I didn't know that they didn't do that at Frenchtown. I told the Pension what the issue was and why I would be doing it and they said yes. I filled out an application, paid it all back, which you can see I got on there and Mrs. Gano talked to them again and from what they told her, I had to have paid it back within the timeframe before 2011, which I didn't know about until a few months ago. I went back and forth with the Pension and to make a long story short, they said "it comes down to your employer". I have to get it approved by the Authority; whether you would pay for my benefits or not because of that loophole. The Pension says they don't really have anything to do with it now because you would be paying for my benefits. That is why we went through all of this. I would be the last person who is eligible for this, I don't think there is anybody else down there that made it close to the timeline; I would be the last one if it was approved.

Mr. Tully - We have to discuss it.

Mr. Hazard – Yes, it is a personnel matter, so we have to discuss it after, in our Closed Session.

Mr. Watts – You would have had that twenty years by that critical date, June 28, 2011, correct? That is the sticking point. What does the Authority have to do?

Mr. Cooper - If I made it by that date, I would retire, and the Authority would pay my benefits.

Mr. Hazard – It mostly comes down to medical?

Mr. Cooper – Yes. I put the time in, but I didn't have the seven months, which I did pay back but it wasn't within that timeframe. I would never have bought it back if I didn't think it wouldn't count. They told me, it wasn't a problem. They never said it had to be before 2011. Mrs. Gano told me that.

Mr. Watts – So, the sticking point is through the employment at Frenchtown?

Mr. Cooper - Yes.

Mr. Watts - Where you aren't getting any credit.

Mr. Cooper - For the first seven months, yes.

Mr. Watts - When did you start there?

Mr. Cooper – June 10th of 1991.

Mr. Hazard – It was because you were on probation at Frenchtown, they said January starts your benefit stuff. Rather than day one starting your benefit stuff.

Mr. Cooper - Exactly.

Mr. Hazard – That is what killed the Chapter 78, the difference between the Chapter 78 paying a percentage of it based on your income, and / or free health care.

Mr. Cooper – From what I understand, when you go off probation here, they would have taken it out of my pay, and pay back those six months. I don't know if they didn't do that at Frenchtown, or if I had the opportunity and nobody told me. I would have bought it back then if I would have known that.

Mr. Tully – We will talk about it and let you know. Thank you for coming in.

Mr. Cooper – Thank you for letting me talk and considering it and have a nice holiday.

1. <u>The Work Session</u> of the Raritan Township Municipal Utilities Authority will be called to order upon the adjournment of the Regular Meeting.

#### 2. <u>Correspondence:</u>

a) To RTMUA Board from Mr. Vern Ainslie regarding Block 15 Lot 22, 181 Highway 31

Mr. Hazard – Mr. Ainslie's house and property, if you are facing the hospital at the light; his house is to the left down by the creek. With Ida, his house was destroyed. I've been there, engineering has been there, Mr. Tully has been there; the oil tank flipped over in the basement.

Mr. Tully – His second floor is even with Route 31, so if you can imagine in Ida, Route 31 was kind of like a dam, so the water was as high as Route 31, so he had water into his second floor and he has the basement so if you can imagine all of that was under water.

Mr. Hazard – He had to vacate the house; he was out of the house from September 2, 2021 until July 25, 2022. He had come to us for help at the Township and we sent him to Blue Acres because that is what our congressman told us to do. For our purposes here though, he didn't know to come to us and ask us to suspend billing. He explained to me after we sent him to Blue Acres that he hadn't paid his bill and I told him to send a letter explaining the circumstances and the dates. I spoke to Ms. Nicaretta about it; what he is asking for is to waive his fees since he was not able to live there. We are looking to waive his fees from September through July. Ms. Nicaretta, from looking at the papers you have here, after waiving he would still owe \$168.50?

Ms. Nicaretta – Yes, he would owe one quarter. Yes, the three other quarters and interest would be waived. I need you to pick a date the payment should be made. Do you want paid by the end of the year before interest accrues?

Mr. Scipione – I think if you give him until December 31<sup>st</sup>, you're still giving him the three quarters, you're still helping him out.

Mr. Tully – I have no problem with that, but he has to have it in by the end of the month.

Mr. Kendzulak, Jr. – Ms. Nicaretta, after the meeting, reach out to him so he knows.

Mr. Madden - SCADA, Mr. Sciss has that handled. The sludge holding tank has been dismantled; the design included leaving what we call the starter ring embedded in the concrete. The contractor called the tank manufacturer to come look at it because he saw some pitting in a couple of areas and he was concerned. They came out and looked at it, I was with them, the guy said it didn't look too bad and they could probably do something. He is going to send a report and we will have to deal with it then. The paving project is done; we are just holding the retainage until they get the final paperwork to us. Flemington Wet Weather Facility; it is an interesting story. We are ready to go with that project but recently, I received an email from Mr. Diehl, apparently, Flemington has been put under an Administrative Consent Order by the EPA for no more discharges of sewer overflows. That is hot off the press. It is not something I have seen here in New Jersey: I know it happens elsewhere in the country. They mean business, they give them ten years and you better be ready, no more overflows.

Mr. Hazard – You may want to explain this to the new members.

Mr. Madden – We have been talking about this with Ms. Carmeli and the DEP. The DEP saying, "Flemington you need to do more". They were doing roads and as they go they were fixing the sewer and the pace was slow but now the EPA is overriding DEP and giving them the Consent Order. The fine I think is \$60,000.00 per day if they don't comply.

Mr. Kendzulak, Jr. – We should be getting that. Shouldn't we be copied on that?

Mr. Madden – This is all new. I have a copy of it I can forward to you. Mr. Tully – So, basically, they are going to give them ten years to fix all of their I & I.

Mr. Frank – Part of that, by getting the ACO, it bumps them up to get grants and loans through the DEP to do all of the work. I was speaking with the EPA inspector who did our inspection and then they did Flemington's. She is saying that they are no longer permitting stormwater facilities. They are trying to phase them out and get rid of them. By them doing all those improvements, we are gradually going to see Flemington shrink, shrink, shrink to the point where we could possibly get rid of it a lot sooner than we anticipated.

Mr. Tully – Less flow to the Wet Weather Facility.

Mr. Kendzulak, Jr. – Ten years to dump all that kind of money in there to stop the I & I?

Mr. Tully – Last time Mr. Diehl was here he said they were doing it road by road. In order to fix all of their I & I, they have to redo all of their roads at the same time. The sewer lines are running right down the middle of all their streets.

Mr. Kendzulak, Jr. - What about the laterals?

Mr. Frank - They will have to be rehabbed.

Mr. Madden – That is where I think they are going to find most of it. They have done this in other parts of the country, Region Two is what covers this area, it is really lagging behind and I think it is partly because New York and New Jersey are tied into that. There is a lot of combined sewers, meaning there is stormwater and sewage in the same pipe. That happens in twenty – three municipalities in New Jersey and in the city of New York. They are starting to phase in these long-term control plans in each of these communities. With the EPA, in other places, they have been doing these dramatic, really costly projects. In Washington, they put a thirty-foot diameter tunnel, two miles long just to store sewer during rain. Then they pump it out and treat it after the rain ends. They don't mess around.

Mr. Tully – Not just the pipe I & I but once they start doing the laterals, they'll find all of the illicit sump connections and get rid of them.

Mr. Madden – It is a tough bind to be in, I was pretty shocked when I saw that.

Mr. Kendzulak, Jr. – The timeline, that ten years will go fast.

Mr. Scipione - So, less sewage coming here?

Mr. Tully – In wet weather, there would be less going to the Wet Weather Facility by the high school.

Mr. Madden – They do reference the 1.08 coming here too. To spend money on the Wet Weather Facility at this time seems crazy with what the

DEP wants us to do at that facility. I think we should take a look at that before we spend that money there, we can use it elsewhere and they have to pay eighty percent. The generator people sent in a price sheet, and we are going through it now. I think, roughly, soup to nuts, it is \$435,000.00 or something like that. That is getting a Caterpillar generator, 750 kw, full installed and then, there is some credit for taking the old one out. I don't know what that number is.

Mr. Hazard - Is that diesel or natural gas?

Mr. Madden – It is diesel. It is quoted as a forty – eight hour tank.

Mr. Hazard – Why would we buy diesel over natural gas?

Mr. Madden – It is a little more reliable. With natural gas, you might have to upgrade your line. It gets complicated; it is about engine size and torque. You do need a high-pressure line.

Mr. Tully – You can get away with it at the Township because you're just running the Administration Building, mostly computers. Here, you are running the whole plant.

Mr. Madden – The aeration diffusers, we finally got in touch with the vendor, and they are sending us information. I know we've been getting the flow meters reinstalled. I know some of them were being repaired, I'm not sure if they are all back yet. There has been some shift in the crews too, there are different people doing it now. We will work with them to get them in and get them calibrated. Keeping an eye on capacity and we are doing pretty good. We had a couple of rain events, and we didn't have any issues. We hit a pretty high number at PS #1, but it kept up with one pump. The cleaning of the septage receiving tank should start next week.
