We're going to need to start looking at that seriously because the DEP is now talking about having an asset management requirement for MUA's and this would be the first phase of what we would need to have. This would be your platform to build your asset management on. It needs to get budgeted so we can get ahead of it before you get slammed.

Mr. Kendzulak, Jr. – We have \$10,000.00 in there for this year. Mr. Frank, you and I had talked briefly about this, as far as there are areas that we don't even have mapped.

Mr. Frank – Newer developments, newer lines.

Mr. Kendzulak, Jr. – What you were proposing was to utilize our forces to go out with hand held GPS and locate the manholes and get what we don't have.

Mr. Frank – When we go and videotape something it's not accurate.

Mr. Kendzulak, Jr. – I don't have a problem with adding this to the budget this year. As far as the camera goes, the same thing. The camera is ten years old and it's down quite a bit and every time it's down we're paying to get it fixed. We need to investigate purchasing it through State Contract. If in fact as we go through the year here, if we find we have some money left over, maybe we can facilitate moving to purchase it this year. The research has to be done on it first.
