### **SLUDGE BOX HAULING PROPOSAL**

NOTICE IS HEREBY GIVEN that sealed bids will be received by the RARITAN TOWNSHIP MUNICIPAL UTILITIES AUTHORITY ("RTMUA") in the Board Room of the RTMUA's Administration Office located at 365 Old York Road, Flemington, New Jersey 08822 for the following item:

The RARITAN TOWNSHIP MUNICIPAL UTILITIES AUTHORITY is seeking a bid price for the provision of supplying, removing, replacing, and hauling of a 30 (thirty) yard, watertight, roll off container with a dump style tailgate. Hauling to be provided by a class 8 (eight) or 80,000 (eighty thousand) pound registered truck, properly licensed and registered with NJDEP. Pickup and hauling to be provided Monday through Friday (Saturdays as needed), between 12:00 pm and 4:00 pm. Hauling will be between Raritan Township Municipal Utilities Authority located at 365 Old York Road, Flemington, New Jersey, and Stony Brook Regional Sewage Authority's Facility located at 290 River Road, Princeton, New Jersey.

Sealed bids will be opened by RTMUA's Senior Crew Chief, for the item listed above on Wednesday, August 27, 2025, at 10:00 am. All bids must be received prior to the date and time specified. Any bids received after the date and time specified will be rejected.

All bids must be addressed to the RARITAN TOWNSHIP MUNICIPAL UTILITIES AUTHORITY and enclosed in a sealed envelope bearing the name of the item bid on the outside of the envelope; and should be accompanied by a Ownership Disclosure Statement, Non-Collusion Certification, Experience Statement, Equipment List, NJ Business Registration Certificate, Certificate of Employee Information Report, Prohibited Russia Belarus Activities and Iran Investment Activities Form, A-901 and other required licensing and Form of Proposal accompanied by a proposal guarantee in the form of a bid bond or certified check for not less than TEN PERCENT (10%) of the amount of the bid, but not exceeding \$20,000.00.

BIDDERS ARE REQUIRED TO COMPLY WITH THE REQUIREMENTS OF N.J.S.A.10:5-31 et seq. and N.J.A.C.17:27 et. seq."

The award of the Contract for providing the above item will be made within thirty (30) days of the bid opening a regular meeting of the Raritan Township Municipal Utilities Authority's Board of Commissioners, who reserves the right to waive formalities and may accept or reject any part or all of the submitted bid proposal(s) as they may determine to be in the best interest of RTMUA.
