5. **Professional Reports:**

a) Attorney –

Mr. Watts - I have a report for Closed Session.

b) Engineer –

Mr. Madden – I will just go in the order of my report. We sent you a letter of recommendation on the SCADA system. We had two respondents; both had proven records and were equally good. The one we are recommending is Morehouse. They are a little cheaper and they are local.

Mr. Tully – Mr. Madden and I looked over the proposals and they are virtually the same when it comes to qualifications. This one is closer; they are in Hopewell. They were all AEA recommended too.

Mr. Madden – I don't think you could go wrong either way. Mr. Frank and I have been doing some back and forth with system improvements. What is on the desk is an updated report on the meters and the flow metering we have been doing over by Johanna Foods. I can summarize what we found. It looks to us like Johanna is not a major contributor of I and I. The rest of it is upstream and that seems to increase during the wet weather and that is where we think we should concentrate the repairs. Mr.

Frank and his crew have ordered some sleeves; there is a new technology, sleeves that can do offset joints, and pipes so they have a way with this flexible bellows if you would, and they inflate it, and it will seal that joint even if it is offset up to an inch on an eight-inch pipe. We are going to try a few of them to see if it is working. Between that and some of the grouting we will be doing and with an outside contractor, we are hoping to get some of this knocked out in the next few months. The capacity, it really hasn't changed; we didn't get numbers for January or February yet. I don't anticipate it changing too much. We are continuing to work on the O & M Manual and we have a couple of projects we are working on designs for, the sludge holding tank, the paving in the main parking lot and driveway. We continue to review 180 Pennsylvania Avenue and there was a homeowner on Barley Sheaf that wanted to connect to the sewer on Ewing Drive. They are offering to extend the sewer approximately two hundred feet, put a manhole in on Barley Sheaf and connect their home to it.

Mr. Tully – From the Township perspective; we are reconstructing Ewing Drive. I would let them know that they have to have everything within Ewing Drive done by July 1st.

Mr. Kendzulak, Jr. – Mr. Madden, going back to the report, I see we have the sleeves, the grouting, and stuff like that. Are there any big finds here?

Mr. Madden – No, I think it is more like death by a thousand cuts. There are a couple of decent bleeders or flows but there isn't anything really jumping off the page at us.

Mr. Tully – Is there a spot downstream of where all of these are where you can meter once you repair these to see what we got back?

Mr. Madden – The thought is, the one that is just above Johanna, we would go back there after we do all of this, and we can see what it is later on.

Mr. Tully – Because we know what it is right now.

Mr. Madden – We could quantify it.

Mr. Tully – The generator replacement? What needs to be changed?

Mr. Madden – The plans were done by an architect. We have to put a spec together. We just want to make sure it is all correct.
