PURCHASE AND DELIVERY OF APPROXIMATELY <u>19,000 LBS.</u> OF DRY POLYMER IN <u>50 OR 55 LB. BAGS, 30 BAGS PER PALLET,</u> to the Authority's main treatment plant. The successful Bidder will be required to enter into a contract with the Authority to supply polymer for a one-year time period (January 1, 2025 – December 31, 2025).

Sealed bids will be opened by the Authority's Chief Operator for the item listed above on Wednesday, August 14, 2024 at 10:00 am. All Bids must be received prior to the date and time specified. Any Bids received after the date and time specified will be rejected.
